●Increase access to affordable, high-quality childcare; and ensure adequate funding for K-12 public education

Economic Development & Small Business Support

1. What specific strategies do you propose to attract and retain businesses in Bend?*

Housing. Without available and affordable housing opportunities for our workforce, businesses can't stay or won't come. In particular, these folks need the opportunity to build equity on their own housing.

By completing the 2nd Street improvements. Improve the Franklin underpass. Build and connect the Hawthorne Bridge. Decide where City Hall is going to be.
